CONVENTION SCHOLARSHIP 2010

The Capistrano Unified Council PTSA (CUCPTSA) is pleased to offer a scholarship program to deserving members of units in good standing to attend the California State PTA convention in Sacramento, California from April 29 - May 2, 2010. This PTSA scholarship is to be used for convention registration, hotel accommodations, meals while at the convention and transportation costs.

We will be awarding three scholarships in the amount up to but not to exceed \$1000.00 each.

ELIGIBILITY

Applicant's unit must be a unit in good standing. A unit is in good standing provided that its bylaws are current or are being processed, tax return has been filed or an extension has been given, audit has been completed, minimum officers are in place and all requested reports have been filed with council. Mentors of the school families are encouraged to nominate deserving PTA/PTSA members provided that member is committed to attending convention.

The applicant must be a current member of a CUCPTSA unit.

Applicant verifies by filling out the application that she/he is ready, willing and able to attend the entire convention and has made employment and/or child care arrangements so that this can be accomplished.

NOTIFICATION

CUCPTSA will contact all successful applicants by email and/or phone no later than March 26, 2010 so that you might take advantage of the state PTA convention early bird registration fee.

PAYMENT OF AWARD

Payment of award(s) will be made directly to the successful applicant upon the submission of receipts of payment of convention registration fees, hotel and airfare and other transportation fees (shuttle to and from hotel to airport, airport parking). If the advancing of these fees is a hardship to the applicant, please state so in the application and if a scholarship is awarded, other arrangements will be made. An amount of \$65 per day for meals will be provided to the applicant prior to the convention based on the following formula: \$10 for breakfast, \$20 for lunch and \$35 for dinner.
