

Membership Due Dates & Awards

1. California State PTA's membership year runs from July 1 to June 30th.

2. Each unit PTA must adhere to the due dates set by their council or district PTA.

Councils and districts set their own due dates in order to meet the State "received in the state office" deadlines.

Fill in the lines below with information you receive from your council or district PTA.

3. Remittances of "per capita" should be forwarded by every PTA at least monthly and are sent through "channels". "Per capita" means per person and is the portion of membership dues not belonging to the unit PTA. The unit PTA remits to the council PTA (or if out of council, to the district PTA.) The council PTA remits to the district PTA. The district PTA remits to California State PTA, who remits to National PTA.

Ready, Set...Remit! Award - 30 Members Oct. 14 Oct. 17

Certificates from California State PTA will be distributed through district PTAs to each unit PTA that remits per capita dues for 30 or more members, through PTA channels to arrive in the California State PTA office from the district PTA by October 30. No application required.

Teachers Matter Award Jan. 13 Jan. 17

One free convention registration will be awarded to units who have both: 1)100% teacher membership and 2)a membership increase by January 31. Remit the roster and per capita for 100% of the school's full-time site-based teachers. Application is required.

Membership & Outreach (Spotlight Award) Jan. 13 Jan. 17

Membership and Outreach, one of the PTA Spotlight Awards, will be presented at the annual California State PTA Convention. Completed applications must be received in the California State PTA office by February 3, 2014. Only units that qualify for the Ready, Set...Remit! Award in the year in which they apply are eligible for a Spotlight award.

100% Membership Award June 9 June 13

Certificates from the California State PTA will be distributed during the summer through district PTAs to each unit PTA that remits per capita dues for memberships equal to or exceeding their school enrollment. No application required.
